- (1) Confirmation of the minutes of the last meeting.
- (2) Discussion on Rules framed by the team of Dr. Jethani and Dr. Mehta for introducing amendment to UKMC Act, 2002 and may be ancillary Rules 2004 for providing legal tooth to C.M.E credit hour allotment; procedure prescribing new fee etc for various components like, issuance of good standing certificate, NOC, etc. processing & communicating MCI orders etc. quick enquiries, for providing enforcement of.,the regulation.

- (3) Panels are required to be preconstituted and notified for enquiring into various categorical offences of medical practitioners, for keeping transparency and avoidance of any charge of favouritism etc.
- (a) Set of experts to be notified for evaluation. of, standardization of workshops and grant of Credit hours to various CME programmes, before hand to minimize controversy of organizers and stake holders.
- (b) All norms and requirements of institutions / centres / hospital etc. conducting accreditation education schemes to be incorporated in rules, so as uniformity of adherence can be made mandatory, and the regulation remain transparent and worthy to be contested if challenged by law.
- (4) To develop library by procuring prescribed books and journals etc which publish cases decided in complaint against medical professionals, by consumer forms, MCI etc, and subject books which can guide the juries in deciding cases, involving technical matter like Dr. Vipul Saha.
- (5) Any other matter deemed fit by members for discussion can be included by members by circulating agenda item amongst members, and bringing the same to be included in meeting.**
- (6) Any other matter with the permission of chair, on the date of meeting.
