(1) Dr. Bhim Singh Pandhi President informed the members that Indian Medical Association, Dehradun had filed a writ petition against the advertisement which was published in newspaper in 2008 for registration of Allopathic practitioners who were working in Uttarakhand, in Nainital High Court. Uttarakhand Medical Council has filed a counter affidavit in Nainital High Court to vacate the abovesaid petition. Dr. Harish Kohli informed the members present in the meeting, that he contacted the petitioners to sort out the solution of Court Case, Dr, Kohli also apprised the full details to all the members to which Dr. Jethani, Dr. Singhal, Dr. R.N. Singh & Dr. Sayana agreed to the suggestion that if the practioners who are registered in U.P. Medical Council are prepared required to apply in Uttarakhand Medical Council on the prescribed application with form 4 of Uttarakhand Medical Council and deposit their require papers for registration in UMC, then the registration will be sent to U.P. Medical Council for N.O.C. After receiving the NOC they can be enrolled in Uttarakhand Medical Council.
