The minutes of the last meeting which was held on 23/11/2014, was read by Dr. Y.S. Bist, Registrar, Uttarakhand Medical Council and some discussion was present.

Dr. B.S. Pandhi started discussion on amendment, of Act2002 & Rules 2004

Mr. S.K. Majumdar has explained the changes in Act, 2002 & Rules, 2004, as Uttarachal shall be substituted at every place in Uttarakhand Medical Council Act, 2002 and Rules 2004 as Uttarakhand.

In short title and commencement :- (IV) The mention of Uttaranchal shall be substituted at every place in Uttarakhand Medical Council Act, 2002 and Rules 2004 as Uttarakhand,.

In Definitions – (to be added)

(18) **“IMC Act, 1956”** means Indian Medical Council Act, 1956 and with all prescribed substitutions, omissions, and amendments etc.

(19) **“Regulation”** means regulations framed for purposes of giving effect to IMC Act, 1956.

- (20) **“Approved Institution”** means a hospital, health centre or other such institution in which a person may undergo the training, if any, required by his course of study before the awarding of any medical qualification to him;
- (21) **“Medical Institution”** means any institution, within or outside India which grants degrees, diplomas or licenses in medicine;
- (22) **“Recognized Medical Qualification”** any of the medical qualification included in the schedules of IMC Act, 1956;
- (23) **“University”** means any university in India established by law and having a medical faculty; or university outside India recognized by Medical Council of India, by inclusion in schedule or issuance of approval letter;
- (24) **“Registration of foreign medical qualification”** means registration made on the basis of qualification and procedure set by Medical Council of India under IMC Act, 1956;
- (25) **“Professional conduct, etiquette and ethics”** means how these issues are prescribed and drafted to be dealt vide the Indian Medical Council (professional Conduct, Etiquette and Ethics) Regulations 2002, and its amendment made under IMC Act, 1956;
- (26) **“CME”** Continuous Medical Education shall mean achievement of medical education training of 30 hrs taken to enhance professional knowledge during 5 years of practice since registration, and / or renewal.
- (27) **“Modern System of Medicine of Surgery”** means qualification because recognized by Medical Council of India, under IMC Act, 1956.
- (28) **“Doctor”** means a person having qualification because recognized by Medical Council of India, and is registered by Medical Council of India / State Medical Councils.
- (29) **“Legal Restrictions”** means restrictions imposed by various law referred to in IMC Act, 1956 and regulations.
- (30) **“Consultation”** shall mean consultation, as is prescribed by IMC Act, 1956.
- (31) **“Rebates and Commission”** shall mean as prescribed by IMC Act, 1956.
- (32) **“Misconduct”** shall mean the same as prescribed by IMC Act, 1956.
- (33) **“Research”** “clinical trials” shall mean research involving patients or volunteers as per ICMR guidelines.
- (34) **“Appeal”** shall include appeal preferred against decision of registrar under U.K.M.C. Act, and shall also include and appeal to M.C.I. preferred by appellants, aggrieved by decision of U.K.M.C.
